Note:

1. The fees of this price list are effective within the territory of the Republic of Belarus and shall apply to the services for the performance of a set of preliminary technical activities related to expert examinations to confirm the compliance of a strategically important medicinal product with the requirements for safety, efficacy and quality (hereinafter — SPTA), preceding the state registration (re-registration) under the standard procedure, conditional state registration (confirmation of conditional state registration), conditional state registration for emergency use, state registration (re-registration) under the simplified procedure, and making changes to the registration dossiers of strategically important medicinal products, performed by the Republican Unitary Enterprise "Centre for Examinations and Tests in Health Service".

2. The cost of services under this price list shall be converted into the payment currency selected for payment at the exchange rate of the National Bank of the Republic of Belarus as of the date of the service agreement.

3. The costs of chemical, toxicological, clinical (medical) trials, bioequivalence and other studies, materials, support activities and services required for performing the SPTA preceding the state registration (re-registration) under the standard procedure, conditional state registration (confirmation of conditional state registration), conditional state registration for emergency use, state registration (re-registration) under the simplified procedure, or making changes to the registration dossier of a strategically important medicinal product, shall be paid by the applicant additionally at the fees approved in the established manner, in accordance with the work descriptions.

4. State duty to the Republican budget for the state registration (re-registration) under the standard procedure, conditional state registration (confirmation of conditional state registration), conditional state registration for emergency use, or state registration (re-registration) under the simplified procedure shall be charged additionally in the manner and in accordance with the current legislation of the Republic of Belarus.

5. Upon the applicant's request, the expert examination of documents for making changes to the registration dossier of a strategically important medicinal product under clauses 4.2, 4.3, 4.5, 4.8, 4.9, 4.10, 4.11, 4.13, 4.16, 4.18, 4.19, 4.20, 4.21, 4.24 of Annex 1 to the Resolution of the Ministry of Health of the Republic of Belarus No. 126 dated December 21, 2021 "On the List of Strategically Important Medicinal Products and the Set of Preliminary Technical Activities Preceding Their State Registration," may be carried out under the accelerated procedure. In case of conducting an accelerated expert examination of documents, a coefficient of 2 shall be applied to the fees set forth in clause 5 of this price list.

6. Upon the applicant's request to correct only technical errors (clerical errors) when making changes to the registration dossier of a strategically important medicinal product, where the submission of a full set of documents is not required under the legislation of the Republic of Belarus, a fee in the amount of 50% of the fee set forth in clause 5 of this price list shall be charged.

7. By order of the Ministry of Health of the Republic of Belarus, the performance of the SPTA preceding the state registration (re-registration) under the standard procedure, conditional state registration

(confirmation of conditional state registration), conditional state registration for emergency use, state registration (re-registration) under the simplified procedure, or making changes to the registration dossier of a strategically important medicinal product, performed by the Republican Unitary Enterprise "Centre for Examinations and Tests in Health Service," and certain names of strategically important medicinal products, may be performed without charging a fee.
